### Affirmations

In order to proceed with the abstract submission, you must agree to the following statements.

- 1) The presenting author of this abstract must be one of the authors listed in the abstract.
- 2) Only up to 2 abstracts can be submitted per author.
- 3) If accepted for poster/oral presentation, the presenting author should register for the conference by 14 Feb, 2020. If the presenter does not register, the presentation will be canceled.
- 4) The abstract will be published as submitted and no language or scientific editing will be done.

### Abstract Form

- 1) Presentation Type: Oral/Poster
- 2) The title must be less than 30 words
- 3) The main body of abstract must not exceed 500 words
- 4) If you have a Table, Figure, Graphic, and Special Character, please embed it all at once in the Abstract and make a PDF file and upload.
